1. CERSAI has been designated as the authority under BUDS Act, 2019 to establish a publicly accessible portal that will provide information on deposit takers.
2. Their portal will include a list of deposit takers operating in India, along with details of their areas and extent of operation.
3. As informed by CERSAI, any scheme or an arrangement pursuant to which funds are managed by a portfolio manager, registered under Securities and Exchange Board of India (portfolio managers), regulations, 1993, falls under Regulated Deposit Schemes.
4. APMI Survey on data collection for the same in Feb'24.
5. CERSAI has accumulated the information regarding deposit takers, which includes the list of intermediaries of SEBI (including PMS), for hosting on BUDS registry portal in a specified format.
